# 1. Ship's Dues

All ships, vessels and any floating equipment must pay dues for entering the port or the deepened channel into the port. The ship's dues are payable by the ship.

Ship's dues are calculated based on GT in accordance with the ship's tonnage certificate. Special dues apply to non-conventional vessels, cf. Item 1.1 below.

The ship's dues are payable at the owners' option:

a. For each individual call, for each period of five calendar days or part thereof:

at DKK 3.65/GT (minimum payment is DKK 1,000 per call)

b. Monthly dues: at DKK 20.10/GT (minimum 20 GT)

Monthly dues are payable in advance and entitle an unlimited number of calls within the calendar month concerned. Maximum time alongside per call: 5 calendar days.

c. 0.51 DKK/GT/day for calling into port at mooring dolphin.

#### 1.1 Special agreements

Non-conventional vessels pay special dues. Please contact Harbour Master's Office for further information.

#### 1.2 Passenger fees

A passenger fee is payable on all passengers arriving at or departing from the port area.

Fee: DKK 2.54 per passenger.

#### 1.3 Exemption from ship's dues

Exempted from ship's dues are:

- a. Ships that exclusively call at LINDØ port of ODENSE to seek medical assistance, to let ashore sick people, shipwrecked and others. The ship is exempted from ship's dues only for a period of 48 hours from calling the port, whereupon the ship pays ship's dues as stated in Item 1.
- b. Ships that exclusively import or export cargo and equipment for the Port's usage and ships used exclusively for construction and maintenance work for the Port's own account.

#### 1.4 Pleasure craft

Pleasure craft which, due to their sizes, cannot stay in a marina and have therefore been assigned by the Harbour Master's Office to a berth in the commercial port must for each year or part thereof pay the rate equal to 12 monthly fees for merchant vessels. The rate is calculated at a minimum of 20 GT.



# 2. Goods Charges

Goods charges are payable on all goods discharged, loaded, re-loaded or in any other way launched or landed in the Port or its channel. The goods charges are payable by the consignee or his local agent, or by the consignor, respectively.

## 2.2 Exemption from goods charges

Exempted from goods charges are:

- Goods for the ship's own
- Goods and equipment for the Port's own use.

Where goods charges have been paid for imported goods, certain instances of seaward export without payment of goods charges may apply - provided a written approval is granted by LINDØ Port of ODENSE. For instance, it is a condition that after unloading, the goods have not been subjected to any processing or handling.

### 2.3 Icebreaker fee

In accordance with the Danish Icebreaking act, no 969 of 25 July 2017, a state fee is levied based on the quantities of goods passing through the individual ports located within Skagen. The icebreaker fee is charged by the quantities of goods shipped in/out of the harbour.

The icebreaker fee is determined by law. In 2019 the fee amounts to DKK 0.05/tonne.



All rates and amounts are given exclusive of VAT and other public dues and charges and may be altered without warning.
