## RESOLUTION - RDC No. 384, OF MAY 12, 2020

Provides for the temporary inclusion of the procedure for issuing a health certificate by documentary analysis, regulated in the Resolution of the Collegiate Board - RDC No. 72, of December 29, 2009, the vessels during the duration of the COVID-19 pandemic.

The Collegiate Board of Agencia Nacional de Vigilancia Sanitaria, in the use of the attributions; check art. 15, III and IV, allied to art. 7, III and IV of Law No. 9,782, of January 26, 1999, and to art. 53, V, §§ 1st and 3rd of the Internal Rules approved by the Resolution of the Collegiate Board of Directors - RDC No. 255, of December 10, 2018, resolves to adopt the following Resolution of the Collegiate Board of Directors, as resolved in a meeting held on May 12, 2018 2020, and I, Substitute Chief Executive Officer, determine its publication.

Art. 1 This Resolution, available, in an extraordinary and temporary manner, during the term of the pandemic of COVID-19, on the issue by documentary analysis only, of the Borde Sanitary Control Certificate (CCSB) or Borde Sanitary Control Certificate (CICSB), national or international vessel, regulated by Resoluc ; that of the Collegiate Board - RDC No. 72, of December 29, 2009.

Art. 2 The issuance of CCSB and CICSB in the form of documentary analysis occurs from the information submitted after notification.

§ 1 ° The pestos, state or regional coordinators of ANVISA have the power to decide regarding the conduct of inspection on board for the issuance of certificates, taking into account the best use of resources during the COVID-19 pandemic.

§ 2 ° In the request where the inspection is not carried out, issue a standardized notification with the list of documents to be presented by the vessel.

Art. 3 In the request for certification, the following documents must be submitted:

I - Potavel a Borde water: reports or records regarding the quality control of the water offered and cleaning of drinking water tanks;

II - Climatization System: spreadsheets or service orders referring to maintenance, operation, Cleaning and disinfection of air conditioning equipment;

III - Food: manuals and standardized operating procedures (SOPs); aferic records temperature of cold rooms and benches where food from the last 7 days was offered;

IV - Medical installation: updated health declaration to the sea; Medical board book with calls from the last 30 days; List of drugs on board; list of existing equipment in the medical facility:

V - Sanitary effluents: International Pollution Prevention Certificate for valid sewage, when applicable, or other documents describing the type of existing system and its operation;

VI - Accommodation: Vessel Cleaning check-list: record of procedures performed and at least 3 (three) photographic records of the installations;

VII - Sinanthropic Fauna Harmful to Health: Updated Integrated Pest Management Program and records or certificates of actions performed on board; and

VIII - S6 Residues : garbage book; solid residues management plan and at least 1 (one) photographic record of the storage area .

§ 1 ° The documents must be presented , preferably in digital format.

§ 2 ° The photographic records of the installations must have a good resolution to provide a view general area of interest .

Art. 4 The CCSB and CICSB will be issued after document analysis, observing the procedures defined in Collegiate Board Resolution No. 72, of December 29, 2009 .

Art. 5 Notwithstanding the issuance of the Certificate, vessels are subject to inspection by the sanitary anytime .

Art. 6 The provisions of this Resolution are applicable to i 6 performed since the publication of the Ordinance No. 188 / GM / MS of the Ministry of Health , on February 4, 2020, during the av i COVID pandemic - 19 .

Art. 7 This Resolution enters into force on the date of its publication to the .

Art 8 ° The validity of this Resolution will cease automatically from the recognition fur Ministry of Health that the situation of Emergency in Public Health of National Importance declared by Ordinance No. 188 / GM / MS, on February 4, 2020, is no longer configured.
