GUIDANCE CONCERNING FILIPINO SEAFARERS ONBOARD VESSELS

AFFECTED BY RESTRICTIONS IN CONNECTION WITH THE 2019-nCoV

OUTBREAK

Considering the recent outbreak of the 2019 Novel Coronavirus Acute Respiratory Disease (2019-nCoV ARD) affecting populations in various parts of the world, several countries have imposed travel advisories which include trade restrictions resulting to the limited entry and exit of ships to and from ports of affected countries, particularly in China and its Special Administrative Regions.

Taking into account that there might be seafarers on Philippine-flagged vessels whose STCW certificate/s shall expire onboard because their planned disembarkation cannot be safely completed in affected ports, or whose STCW certificate/s shall expire onboard during the period of their voyage to and from the next convenient port where disembarkation of the concerned seafarer can be safely carried out, the Administration may issue the necessary dispensation permit upon application of their respective Manning/Crewing Agencies and Shipping Companies pursuant to MARINA Circular No. 2011-02.

Moreover, all local ship management and manning companies should immediately coordinate with the Flag State Administration of their affected vessels for whatever arrangement and extension of all necessary assistance to all seafarers, particularly Filipino seafarers with expiring STCW certificate/s.

This Administration likewise advises the Master of the concerned vessels to request a written statement from the Port or Immigration Authorities that disembarkation is not permitted due to the prevailing situation. This written statement can be presented as an evidence to the next port of destination or convenient port where the concerned seafarer can disembark and be replaced by a new crew.

Finally, all ship owners/shipping companies, port state control and flag state authorities, other entities and individuals concerned, especially Filipino seafarers currently onboard vessels operating within the affected areas, are encouraged to exercise precautionary measures necessary to prevent transmission of the disease.

Please be guided accordingly.

Guiding Principles (step-based approach) Developed by International Association of Classification Societies (IACS) Regarding Surveys and Renewals of Certificates During the COVID-19 Pandemic

Please be advised that the International Maritime Organization (IMO) issued Circular Letter No.4204/Add.19 Coronavirus (COVID-19), entitled: Guidance for Flag States Regarding Surveys and Renewals of Certificates During the COVID-19 Pandemic.

Heeding the call of the IMO Secretary General to limit the issuance of short-term certificates or other measures to specific situations caused by the COVID-19 pandemic and for relevant decisions to be made on a case-by-case basis, please be advised that MARINA Advisory No. 2020- 30, entitled: Further Extension of Statutory Certification and Services as a Temporary Contingency Measure During the COVID-19 Pandemic is hereby modified. We hereby adopt the Guiding Principles (step-based approach) developed by the International Association of Classification Societies (IACS) when considering whether to permit statutory certificate extension beyond three (3) months.

It is recalled that due to the challenges caused by the COVID-19 pandemic in the conduct of surveys, the MARINA had introduced alternative arrangements through MARINA Advisory No. 2020- 25 and MARINA Advisory 2020-30 allowing the issuance of short-term certificates or extending certificates beyond the statutory maximum.

With the issuance of IMO Circular Letter No.4204/Add.19, the MARINA, in observance of the prevailing principle of maintaining the highest level of compliance with existing statutory and classification provisions, shall consider the Annex providing for the Guiding principles on the provision of technical and implementation advice to flag States when considering whether to permit statutory certificate extension beyond 3 months.

As stated in the said Circular and the recommendations presented by its Recognized Organizations (ROs), the MARINA as the flag State will be following this step-based approach in order to lead to an informed decision-making process when deciding whether to permit the extended operation of the ship beyond the three (3) month statutory period:

- Step 1: Have all options for completing the survey and renewing the certificates (using all available means permitted by the Administration) been exhausted?
- Step 2: For each case of demonstrated exceptional circumstances and/or force majeure, examine the available information on the ship and its history as a means to considering alternative evidence on the conditions of the ship in lieu of completing the survey and offering a recommendation to its flag State.
- Step 3: Consider how the requirements of the convention and classification rules can be shown to be met in the interim without changing the requirements themselves.
- Step 4: Use verification requirements which are based on accepted survey procedures
- Step 5: Consider alternative evidence for assessing compliance to account for:
 - a. Confidence (how accurate a representation of the actual condition is this?)
 - b. Durability (i.e. how long can this be considered a valid evidence before revalidation is required?)
- Step 6: Concluding with an overall documented evidence on which the extension period and any service restrictions are based.

Further, the MARINA, its ROs and the shipowners/operators shall continue to improve its mechanism to ensure effective communication to allow consultation among all parties.

Finally, all survey certificates that were issued during the Enhanced Community Quarantine (ECQ) shall remain valid subject to periodic review. All statutory certificates that were issued prior to the issuance of this Advisory shall likewise remain valid.

Crew Change During the COVID-19 Pandemic

As the coronavirus (COVID-19) pandemic continues and noting the substantial challenges being faced by the global shipping industry to effect crew changes, the Philippines, through the cooperative and collective efforts of the following agencies – the Department of Justice and the Bureau of Immigration; the Department of Labor and Employment (DOLE) and the Philippine Overseas Employment Administration (POEA) and the Overseas Workers Welfare and Administration (OWWA); the Department of Transportation (DOTr) and the Maritime Industry Authority (MARINA), and the Manila International Airport Authority (MIAA); the Department of Interior and Local Government (DILG); the Department of Health (DOH) and the Bureau of Quarantine and the Philippine Health Insurance Corporation (Philhealth); the Philippine Coast Guard (PCG); and the Department of Foreign Affairs – has caused the issuance of Joint Circular No.1, providing guidelines for the establishment of the Philippines Green Lane to facilitate the speedy and safe travels of seafarers, including their safe and swift disembarkation, and crew change during the COVID-19 pandemic.

Joint Circular No. 1 was issued to give attention to the recommended framework of protocols for ensuring safe ship crew changes and travel during the coronavirus (COVID-19) pandemic under IMO Circular Letter No.4204/Add.14 and to recognize the vital importance of the seafarers to the maintenance of global supply chains.
