# **SPEAKERS**



#### **Baris Soyer**

Professor Soyer is the Director of the Institute of International Shipping and Trade Law at Swansea University (www.swansea.ac.uk/law/istl). He is a member of the British Maritime Law Association and British Insurance Law Association. He is the author of Warranties in Marine Insurance published by Cavendish Publishing (2001), Marine Insurance Fraud published by Informa Publishing and of an extensive list of journal articles published in elite journals such as Lloyd's Maritime and Commercial Law Quarterly, Journal of Business Law, Cambridge Law Journal, Edinburgh Law Review,

Law Quarterly Review, Torts Law Journal and Journal of Contract Law. He sits on the editorial boards of the Journal of International Maritime Law, Shipping and Trade Law and editorial committee of the Lloyd's Maritime and Commercial Law Quarterly (International Maritime and Commercial Law Yearbook). He currently teaches Admiralty Law, Charter parties: Law and Practice and Marine Insurance on the LLM Programme, and is the Director of Shipping and Trade LLM programmes at Swansea.



#### **Zheng Rui**

Dr. Zheng Rui (Ph.D. in Law, Swansea University, UK) is an Associate Professor and Director of the Maritime Law Teaching & Research Section at the School of Law, as well as the Deputy Director of the Institute of Maritime Law at Shanghai Maritime University. Combining profound academic expertise with extensive practical experience, he acts as an Arbitrator and Mediator for the China Maritime Arbitration Commission (CMAC) and represents China in the International Working Group on "Legal Issues Concerning Mobile Offshore Renewable Units" under the

Comité Maritime International (CMI).

Dr. Zheng specializes in research on maritime law, insurance law, and maritime arbitration law. He has authored/translated 4 academic monographs and has published nearly 20 scholarly articles. Concurrently, he holds positions in prominent professional organisations, including: Deputy Secretary–General and Standing Member of the China Maritime Law Association; Member of the China Association of Insuance Law; and Vice Chairman of the Insurance & Legal Committee of the China Shipowners' Association. Notably, Dr. Zheng is committed to public legal education. He has authored approximately 170 original online articles analysing maritime law cases and topical issues. These articles have received over 200,000 cumulative views, significantly enhancing the accessibility of specialised knowledge and his influence within the shipping industry.
